- Bids received after due time and date or bids without Bid Security in shape of CDR or CDR less than required amount or copy of CDR or Bid Security in shape of Cheque / Cross Cheque / pay order / Demand Draft / Banker's Cheque shall be summarily rejected.
- Vendors must quote their rates on the company letter pad / tender form according to the specifications. Hand written quoted rates will not be accepted.
- The sealed tenders must reach in the Vice Chancellor office through Registered post / courier service within stipulated time.
