GC Women University Sialkot intends to solarize Fatima Jinnah Campus on an ESCO model and seeks Technical and Financial proposals to Energy Services Companies (ESCOs) for financing/investment, design, supply, installation, construction and commissioning as well as Operation and Maintenance (O&M) through competitive bidding process on the basis of **Single Stage Two Envelopes** for grid tied solar PV systems.

Firms/ Companies/ JVs/ legal entities or interested parties having relevant experience registered with PEC in category C-5 or above may apply along with all the documents as required in RFP documents. A complete set of RFP and Power Purchase agreement (PPA) documents can be obtained by well reputed interested firms/contractors on submission of written application to Project Director, GC Women University Sialkot upon deposit of a non-refundable fee of **PKR 2,000/-** in The Bank of Punjab **Account # 6580208768600042** at Paris Road Branch Sialkot through challan form or online fee deposit or Pay order / Demand Draft of Prescribed fee in favor of **"Treasurer GC Women University Sialkot"** during office working hours along with the following information / documents:

- i. Copy of Registration certificate with Pakistan Engineering Council (PEC) in relevant Category along with latest renewal letter.
- ii. Copy of Registration with Securities Exchange Commission of Pakistan (SECP) / Registrar of Firms whichever is applicable.
- iii. Copy of Registration with FBR (Income Tax) and Punjab Revenue Authority (PRA).
- iv. Copy of Professional Clearance Tax Certificate with Excise and Taxation Department for current Year.
- v. A certificate / affidavit that the firm is not blacklisted and not involve in litigation by any Govt. / Autonomous Body.

Bids/ proposals will be evaluated by using Single stage two envelope procedure (Separate sealed envelope marked as **"Technical Bid"** and **"Financial Bid"**) as per PPRA rules clause 38(2)(a). Both technical and financial bids/ proposals in sealed envelopes clearly mention Technical and Financial bids/ proposals must be delivered to the **VICE CHANCELLOR OFFICE, GOVT COLLEGE WOMEN UNIVERSITY SIALKOT** at or before **April 18, 2024** on **11:00 am** and technical bids/ proposals will be publically opened on the same day at **11:30 am** in the presence of bidders or their representatives, who opts to be present and attend.

Incomplete and late technical and financial bids/ proposals will not be entertained. Earnest Money for an amount of **Rs. 1,000,000/- (One Million Rupees only)** of approximate rough cost in shape of CDR in favor of Treasurer GC Women University Sialkot must be accompanied with Technical bid.
